The Maternal and Children's Provincial Program – Education & Research Department, in partnership with the University of Saskatchewan College of Medicine, Department of Obstetrics & Gynecology, is pleased to announce collaboration as successful recipients of the [Healthcare Insurance Reciprocal of Canada \(HIROC\) Collaborate Safety Grant](#) and Mitacs Business Strategy Internship (BSI) funding.

Our project, **MatSK Connect: A Human-Centered Prenatal EHR for Interprofessional Excellence**, aims to develop standardized provincial perinatal forms and a provincial perinatal pathway, with the long-term vision of evolving toward a provincial perinatal electronic health record.
